#### **Old Business:**

- Technical Team Borzeka reported
  - o Villa Park NRI requirements no further applications received
  - o Kane County zoning changes have increase
  - Tracking workload to determine what NRI fee schedule changes will be implemented on Jan 1, 2025 and whether no report letters should resume being charged for.
     Discussion ensued. Awaiting results of the audit. Last NRI fee adjustment was 2021.
- Sugar Grove MOU discussion. Proposal is on hold pending KDSWCD/Sugar Grove administration meeting to determine how to move forward after the unapproved communication by Director Piper on the Crown project. A "loss of trust" of KDSWCD by Sugar Grove was reported. Discussion ensued. Piper raised a concern of the appearance of conflict of interest for Chairman Konen due to family connections in Sugar Grove. Soliz assured those connections were distant and irrelevant. Konen and Gerdts to schedule meeting with Sugar Grove to determine next steps.
